



For US donors: How to donate to the Human Rights Measurement Initiative (HRMI) via The Gift Trust

The Gift Trust, a New Zealand registered charity and philanthropic trust, has set up a fund with the US donor-advised fund RSF Social Finance to allow US tax residents to donate to charitable causes in New Zealand and receive a US tax benefit. The account is called 'Friends of The Gift Trust NZ' and any donations to it will receive a US tax receipt and will be eligible for US tax benefits. Donations can be made in cash, shares or securities.

Donations to the fund will be accumulated and then transferred to The Gift Trust in NZ quarterly, to be allocated for the purposes that the donor advises. Donors can request that their donation be transferred to HRMI by specifying the recipient as Motu Economic and Public Policy Research (Motu). HRMI is hosted by Motu, a not-for-profit charitable research institute. The Gift Trust has conducted due diligence on Motu to ensure the gift is charitable. Donations will be made quarterly, after deducting the fees below.

Minimum amounts for donations

Due to the administration and fees involved, the minimum donation that donors can give is US\$1,000. Before donations can be distributed to Motu they will need to accumulate to NZ\$5,000, to ensure cost effectiveness.

Fees

Two sets of fees apply - The Gift Trust will charge a fee to cover our due diligence on Motu and the gift, and to receive and transfer the funds. RSF Social Finance will charge a fee to receipt the donations in the US and transfer them to The Gift Trust.

The Gift Trust fee:

Donations up to \$99,999	3% of the donation value
\$100,000 to \$499,999	2% of the donation value
Over \$500,000	1% of the donation value

RSF Social Finance fee:

RSF will charge 2.6% per annum of the funds held in the account. This fee is per annum, so if the funds are held for 1 month by RSF before being transferred to NZ, you will only pay 1/12th of 2.6%. See below for fee examples. There is also a transaction fee of US\$350 per quarter (split between all the donations transferred that quarter).
